 - o VP received the corrected PDF from AHS on 20th March 2020

- VP has sent the PDF to Cr Matt Constance, Glen Miller[MBRC], Alex Wisniowiecka [MBRC] and all the volunteers who have been coming to bushcare plus ex students who have shown an interest in our project
